Presentation Synopsis

With the Bloomberg Economics GDP tracker showing global growth in 1Q19 running at its weakest pace since the global financial crisis, the shipping industry needs to prepare for the implications and any potential fallouts from the current global macroeconomic environment. Bloomberg Speakers will explore the global economic outlook and discuss if any positives for shipping industry can be found in the event of a Sino-U.S. trade war resolution.

Shipping Markets:

The Bumpy Journey Towards IMO2020

Presentation Synopsis

The speaker, a prominent shipping markets analyst from Clarksons Platou, will explore key themes in the current shipping markets including how shipping markets in general are responding to a 'drag' from geopolitical issues; impact on key commodities such as oil which filter into bunker prices; how potential demand growth is arguably being 'constrained' by macroeconomic uncertainties; exporter issues (e.g. the Vale crisis); and last but not least IMO2020.

Despite short-term downside in some markets, the speaker will share views on future market outlook, including an arguably strong future upside should current uncertainties be removed.

Shipping and the Environment – A Step Change

Presentation Synopsis

The speaker, who is Secretary-General of ICS, will discuss shipping and the environment looking at the fast approaching IMO 2020 Sulphur Cap and also the longer-term commitment of industry to reduce greenhouse gas emissions by 50% by 2050. The next 10 years will see huge changes in the industry at an accelerated pace.

2020 will be a regulatory game changer with profound effects on the economics of shipping. Unless implemented consistently, ensuring a level playing field for shipping companies, there will be scope for significant market distortion. Beyond 2020, the industry faces challenges on an unprecedented scale to meet the IMO strategy agreed a year ago. The speaker will discuss both short term measures and the need for new technologies.
